- Ownership as applied for must correspond with the ownership on the registration application.
- Certificate of eligibility are permanent when issued to each horse. A transfer procedure is required to update ownership of horses purchased or sold. The certificate will be returned to the recorded owner. Please complete the Transfer Report Form and mail to ARHA with original Certificate Of Eligibility and fees.
- Owner must enclose legible photocopy of breed registration papers. Form must be filled in accurately and legibly. All of the sections must be completed.
- Registration fee must accompany form. Make check payable to: ARHA. Registration fees are non-transferable and non-refundable.

 Horses 2 & Over.....\$25.00
- Horses must be quarter type registered with AQHA, APHA, ApHC, IBHA, ABRA, PBHA, PTHA (stock-type), NQHR.
