MANEUVER SCORES -1½ Extremely Poor, -1 Very Poor, -½ Poor, 0 Correct, +½ Good, +1 Very Good, +1½ Excellent

1/2 Point Penalties:

- A. Failure to remain more the 20 ft from fence when stopping or doing a rollback
- B. In run to end, failure to change leads by 1 stride
- C. Starting a lope departure at a jog or exiting rollbacks up to 2 strides
- D. Delaying lead change by 1 stride
- E. Over or under spinning by 1/8 of a turn

1 point Penalties

- A. Delaying lead change from start to 1/4 of circle
- B. Over or under spinning by 1/4 turn
- C. Failure to be on the correct lead in curve towards run down
- D. During rundown in arena, failure to change leads beyond 1 stride but prior to next maneuver

2 Point Penalties

- A. Break of gait
- B. Delaying change of lead from start to 1/2 of circle
- C. During the run to end of arena, failure to change lead prior to the next maneuver.
- D. Jogging beyond 2 strides, but less than 1/2 of circle or 1/2 the length of the arena.
- E. Failure to go beyond markers on end stops
- F. Freezing up in spins or rollbacks

3 Point Penalties

- A. Delaying change of lead from start lead from start to three-fourth (3/4) of circle.

4 Point Penalties

- A. Delay change of lead for a complete circle.

5 Point Penalties

- A. Spurring in front of the cinch
- B. Use of free hand to instill fear
- C. Holding Saddle with free hand
- D. Kicking Out

-0- Score

- Failure to complete Pattern
- Performing Maneuvers in unspecified order
- Over spins of more than 1/4 turn
- Equipment Failures
- Inclusion of additional maneuvers
- Jogging more than ½ circle or ½
- Arena length while starting a circle, circling or executing rollback
- Fall to ground by horse or rider
- Blatant Disobedience
- Balking or Running Away
- More than 1 finger between reins or more than 1 hand on reins except for JR horses ridden with snaffle/hackamore or mecate with snaffle
