**RUSH SERVICES:** ARHA Certificate Of Eligibility will be mailed within 3 (three) weeks of the date it has been received by the office. ARHA offers rush services which include an official confirmation (Proof To Show) being emailed and is to be used until the original Certificate Of Eligibility certificate is received by mail. Registered horses may also apply for their Certificate Of Eligibility (registration papers) at the show. Show secretary will have all required forms at show, there will be a \$10 rush fee for this.

Video showing horse walking, trotting and loping must be emailed to [arhacontact@aol.com](mailto:arhacontact@aol.com). ARHA reserves the right to deny any horse they deem a non-western type and/or revoke certificate at any time. Fees are non-transferable and non-refundable. Grade/Unregistered horses CAN submit Certificate Of Eligibility Application at any ARHA approved show or competition but must be inspected by show management prior to entry.
